

CONTINUING EDUCATION (CE) FACT SHEET 2026 REAL ESTATE BROKER LICENSE RENEWAL

- The 2026 Broker Renewal deadline is April 30, 2026.
- Prior to renewing a license, the licensee shall complete the required courses as described below.

Summary of Continuing Education (CE) Requirements

If first issued a Broker License prior to November 1, 2023:

- **12-hours of CE is required:**
This must consist of a 6-hour Core* course and 6 hours of elective courses, including a [Sexual Harassment Prevention Training](#).
Note: The Sexual Harassment Prevention Training may be counted towards elective hours if completed through an approved education provider.

*A 4-hour Core course taken between May 1, 2024 and June 30, 2025 shall satisfy the Core requirement and will need 8 hours of elective courses, including a Sexual Harassment Prevention Training for this renewal.

If first issued a Broker License between November 1, 2023 and October 31, 2025:

- **45 Hours of Post License Education is required**

Note: The Post License curriculum includes the required 1-hour of Sexual Harassment Prevention Training

If first issued a Broker License on or after November 1, 2025

- **A license issued during this period will have an expiration date of 4/30/2028**
- **45 Hours of Post License Education is required to be completed by 4/30/2028**

Note: The Post License curriculum includes the required 1-hour of Sexual Harassment Prevention Training

Certification of Compliance with Continuing Education (CE) Requirements

- 1) Each renewal applicant must certify on the renewal application full compliance with the CE requirements.
- 2) Attorneys admitted to practice law pursuant to Illinois Supreme Court rule are exempt from CE, but must certify on the renewal application full compliance with the CE requirements.
- 3) The Department may require additional evidence demonstrating compliance with the CE requirements. It is the responsibility of each renewal applicant to retain and produce evidence of such compliance upon request.
